Mayor Parker Endorses Center City Sixers Arena

Philadelphia Mayor Cherelle Parker announced via social media that her administration has reached an agreement with the Philadelphia 76ers over their proposed Center City arena. City Councilmember Mark Squilla (District 1), who represents Chinatown and the proposed arena site, has committed to making drafts of legislation for the arena public 30 days before introduction, making October 24 the earliest possible date for introduction.

Former Project HOME VP Appointed to Lead OHS

Mayor Cherelle Parker appointed former Project HOME Executive Cheryl Hill to lead Philadelphia's Office of Homeless Services (OHS), tasked with managing homelessness programs and addressing the department's overspending issues.

Inquirer Editorial Board Calls for Proper Funding for SEPTA

The Philadelphia Inquirer's Editorial Board contends that adequate funding for SEPTA is vital for the city's overall economic well-being. They warn that cuts and fare increases could lead to diminished ridership and worsen financial difficulties and that neglecting SEPTA's budget crisis might result in broader regional problems, such as increased traffic congestion and stunted economic growth.

PennDOT to Invest \$14M to Install EV Chargers in Philadelphia

PennDOT plans to invest at least \$14 million in federal funds to install electric vehicle (EV) chargers in Philadelphia by 2026, while the City remains cautious about prioritizing electric vehicle infrastructure over other transportation options.

\$100M Plan Would Revamp Historic District with Bike Lanes, Green Spaces, New Plazas

Historical Commission Approves Washington Square West Historic District

Gates Foundation Backs \$35M Investment in Philadelphia-Area Biotech Company

Radiant Biotherapeutics, a biotech firm with labs in Toronto and a U.S. office in West Chester, secured \$35 million in new financing, including significant support from the Gates Foundation. The funds will advance its Multabody technology, designed to target diseases like cancer, COVID, and HIV with enhanced binding capabilities.

Election Update

VP Harris Visits Philadelphia for WHYY/NABJ Interview, National Voter Registration Day at CCP

On Tuesday, Vice President Kamala Harris participated in an interview hosted by WHYY and the National Association of Black Journalists (NABJ), answering questions from a panel on critical topics including the economy, Gaza, reparations, reproductive rights, and race relations, while highlighting the achievements and future plans of the Biden-Harris Administration. She also visited the Community College of Philadelphia (CCP), where she engaged with Philadelphia-area students and reminisced about her first campaign experience on National Voter Registration Day.

Philadelphia Democrats Run Unopposed in State House Special Elections

Democratic candidates Keith Harris, a community activist, and Andre Carroll, a city and state government veteran, are running unopposed in special elections to fill two vacant Philadelphia state House seats previously held by Representatives Donna Bullock and Stephen Kinsey, both of whom resigned in mid-July to pursue new jobs. The elections are crucial to maintaining the Democrats' narrow 102-101 majority in the state House.
