Earlier in his career, he spent nearly three years as a health insurance specialist at CMS within the Department of Health and Human Services; and three and a half years working for Senate Democrat Sheldon Whitehouse, (D-R.I.) as legislative assistant/counsel for the senator's Health, Education, Labor and Pensions (HELP) Committee and Aging Committee work.
