Rob's practice involves a wide range of business litigation matters in federal and state court, including contract disputes, corporate governance litigation, antitrust litigation, and other complex torts and business disputes, including at the trial and appellate levels. ## Experience

Defeated a motion for a status quo order seeking reinstatement of an LLC manager in the Delaware Court of Chancery on behalf of a real estate investment fund in a dispute with a joint venture partner.

Won at trial in a major voting rights case, *Nairne v. Ardoin*, challenging Louisiana's state legislative maps under Section 2 of the Voting Rights Act. At the conclusion of the trial, the U.S. District Court for the Middle District of Louisiana found that, while the proportion of Louisiana's Black population increased from 2000 to 2020, the Enacted Senate and House Plans unlawfully diluted the Black vote such that these population gains were not reflected in the Enacted Plans. The Court enjoined the use of the Enacted Senate and House Plans and allowed the State a reasonable period of time to draw new plans to comply with Section 2 of the Voting Rights Act. Our team handled this case in conjunction with co-counsel from the ACLU, NAACP Legal Defense & Educational Fund, and Harvard Law School Election Law Clinic, and two Louisiana civil rights attorneys.
