He represents suppliers, subcontractors, general contractors, and project owners in state and federal court, and before the American Arbitration Association, CPR arbitration, and in International Chamber of Commerce arbitrations.

Most recently, Schiff defended a Spanish civil contractor in a complex, years-long multiparty indemnity claim involving highway construction in both state and federal courts and in ICC and CPR arbitration, reducing the client's liability from more than \$600 million to a settlement of less than one percent of the original claim.
