Experience

Obtained early dismissal for broker entities in a case alleging negligence in contract procurement.

Secured a favorable resolution for foreign equipment manufacturing company client seeking damages for breach of contract and unjust enrichment.

The plaintiffs whose claims against the county centered on an alleged failure to warn of the potential for a dangerous landslide agreed to dismiss those claims (reserving the right to appeal) after the court ruled in the county's favor on several pre-trial motions.
