Wendy Venoit will speak on the "Don't Let Damages Get You Down - Sticky and Tricky Damages Theories in Construction Litigation" panel. Wendy will discuss the types of damages for construction projects, how quantum meruit differs from a "total cost" claim, and arguments for getting around the limitations of liability clauses.
